ASSUMPTION of RISK and RELEASE of LIABILITY by Participant, Volunteer and Spectator

The undersigned desires to participate in, volunteer, assist, observe, or be at places and premises (the "premises") where the **SHERIDAN WYO RODEO™, WORLD CHAMPIONSHIP INDIAN RELAY RACES™, and its RELATED EVENTS AND PRODUCTIONS (the "event")**, take place or occur. In consideration of my being allowed to be on any premises, and to participate, volunteer, assist, and/or observe any event, **including but not limited to the Sheridan WYO Rodeo, the World Championship Indian Relay Races, Sheridan Wyo Rodeo Wranglers events, Spurs events, Sheridan WYO Rodeo Royalty Organization events, or any other event**, I agree as follows:

I acknowledge that the Sheridan WYO Rodeo, Inc. promotes, produces and sponsors a PRCA professional rodeo, the World Championship Indian Relay Races, equestrian groups, rodeo royalty events, horse competitions, parades, roping, polo, and other events (the "events") at various locations. **I understand** that the events involve horses, livestock, moving vehicles, equipment and machinery, and other people who participate, volunteer, or observe the events. **I understand** that the events are dangerous activities which can cause serious injury and/or death to persons and livestock, due to the inherent risks of the events, independent and unpredictable behavior of horses, cattle and other persons, as well as premises and ground conditions, regardless of training and preparation. **I understand** that, even with the strict observance of event rules and safety rules, injury to myself, to my livestock and to my property is still possible.

I assume all risks and responsibility for the safety of myself, my livestock and my property, as well as the safety of the person, livestock and property of any spouse, dependent, or minor child who accompanies me.

I UNCONDITIONALLY RELEASE, HOLD HARMLESS, and AGREE TO INDEMNIFY the Sheridan WYO Rodeo, Inc., Sheridan WYO Rodeo Royalty Organization, Inc., Wranglers, Sheridan County, Sheridan County Fairgrounds Association, Northern Wyoming Community College District, the City of Sheridan, Whitney Benefits, Inc., the Owner(s) of any premises, grounds, properties or facilities where the events may occur, and all of their directors, officers, agents, employees, members, commissioners, sponsors, contractors, related parties, affiliates, spectators, volunteers and other participants, (collectively referred to as "**Releasees**") from all claims of legal liability for bodily injury or death sustained by me, my spouse, dependents or minor children, or damage to my property and livestock, whether foreseeable or unforeseeable, due to the intentional or negligent conduct and actions of myself, Releasees, other persons, livestock, conditions and hazards of any premises, or the use of any livestock, horses or equipment that may be rented or borrowed from the Releasees or others.

I acknowledge that I am voluntarily on the premises, and that I voluntarily participate in the events. I acknowledge that my participation in any event is not a service of a special or highly necessary nature for which **Releasees** owe a special duty to me or the public.

I understand this Release shall be binding on me, my personal representatives, heirs, successors and assigns. I agree that if any part of this Release is found not to be legally binding, then all other parts of this Release shall be binding, and continue in full force and effect.

I have fully informed myself of the contents of this Assumption of Risk and Release of Liability. I understand that it is a release of all claims and that I am giving up certain legal rights. I have signed this release voluntarily. **I am of lawful age** and legally competent to sign this Release. **If I am signing for a minor, I am a parent or legal guardian of the minor.**
